- I. Name of the Society
 The name of the Society shall be "ASSOCIATION FOR SOCIAL SERVICE & REHABILATION OF THE AGED (ASSRA)"
- II. Regd. Office

 The registered office of the Society shall be situated in the National Capital Territory of Delhi and at present it is situated at \$108/1,8aba Canganath Market,Munirka, New Delhi-110 067.
- III. Area of operation :In the National Capital Legitory of Delhi
- IV. Aims & Objects

- The aims and objects of the Society for which it is set up shall be to establish, run, manage and administer; a de communication net work-without any profit motive and without distinction of any caste, creed, colour or race, to disseminate information, to educate people in, the area of development in order to improve the capality of life of the deprived and disadvantaged people & mainly the elders & the Deprived Child in need.
 - In furtherance of the above objects the Society shall have the following powers:
 - To undertake programs for development and welfare of the special categories of people-scheduled castes, scheduled tribes, other backward castes, minorities, disabled, the street and neglected children, drug addicts, elders, slum dwellers, prison inmates, mentally ill or depressed persons etc; and institute preventive, diagnostic, therapeutic, rehabilitation and follow-up services for all the above vulnerable groups.
- 2.2 To institute programs for full participation and integration of women as both agents and beneficiarles in the development process; promote strategies for equal opportunities and human rights of women; work towards eradication of all forms of discriminating and violence (both hidden and overt) against women; launch and participate in programme for gender equality; and mobilize national and International efforts to enhance the overall status-social, economic, educational, legal, and political-of women to ensure their empowerment.
- 2.3 To implement and support plan of action advocating the three goals of 'survival, protection and development' of children; launch special schemes to take care of

gender specific needs of the girl child; improve the nutritional and health status of child; and protect the rights of the child.

- To adopt and implement the goal of 'education for all' through a strategy of 2.4 universalizing elementary education, adult and continuing education and nonformal education; stress on women's education; strengthen vocationalisation of education; develop of open/distant education; promote languages; Improve and integrate science, environment and population education; strengthen value education or cultural inputs or artistic expression in educational content and process; develop relevant, flexible and Innovative teaching-learning; educational methods, materials, aids, kits and technology (including multi-media ones); encourage and introduce physical education and yoga; establish and manage educational institutions, including schools colleges and resource centers; and develop and effective linkage between education and other development programs.

- To establish, undertak, execute and hold charitable trust, institutions, programs, 2.8 projects and to support or aid in the establishment and to collaborate with other and to provide funds and other assistance in establishing such trusts, and funds.

To take all such steps as may from time to time be reasonably necessary for procuring contributions iron the public, by way of donations, subscriptions, Odvices, bequests or in any other manner, to the funds of the Society.

To arrange, hold and provide for or join in arranging, holding and providing for formal and non formal education, vocational training and income generation programs, lectures, exhibitions, meetings, classes, conferences and other things reasonably necessary for the advancement of the object of the Society.

To quide and give stipends to research students in the field of work of the society and if necessary to affiliate with and collaborate with other societies and. institutes.

- 2.12 To establish, construct, acquire, take over, conduct, maintain and administer educational institutions in all its branches, and facilities for the spread of knowledge.
- 2.13 To carry out all charitable activities including relief to the poor, education, medical relief, advancement of any other object of general public utility.
- 2.14 To undertake projects for the development of poor people in the field of agriculture, Fishery, Poultry, Horticulture, Low Cost Housing, Small-Scale Industries etc.
- 2.15 undertake projects for the conservation water through watershed/harvesting programs.
- 2.16 To undertake projects and do research in the field of Rural Industrialization, Rural Electronics, Rural Electrification, Bio-technology & Bio-diversity
